## AT-A-GLANCE REPORT

In January 2022, IERBC conducted 24 Focus Group phone surveys interviewing residents within disadvantaged communities in Riverside and San Bernardino County to determine the potential for low-income residents, who are the majority of unconnected and under-connected households in the region, to reduce vehicle trips and therefore decrease greenhouse has (GHG) emissions, if they had access to high-speed internet infrastructure and were digitally proficient.

- THE PARTICIPANTS IDENTIFIED A TOTAL OF <u>83</u> VEHICLE TRIPS COULD BE AVOIDED BY USING THE INTERNET AT HOME.
- SHOPPING, PAYING BILLS, BANKING, SCHOOL AND EDUCATION, WORK, AND MEDICAL RANKED THE HIGHEST FOR POTENTIAL TO REDUCE VEHICLE TRIPS.
- <u>10</u> PARTICIPANTS IDENTIFIED THEMSELVES AS "ESSENTIAL WORKERS"
- THE AVERAGE HOME INTERNET BILL WAS \$86 PER MONTH.
   (ONLY <u>1</u> RESPONDENTS HAD INTERNET SERVICE UNDER \$25 PER MONTH)
- <u>ALL</u> PARTICIPANTS HAVE INTERNET AT HOME, BUT ONLY A FEW KNEW ABOUT ANY DISCOUNTED PROGRAMS FOR LOW-INCOME HOUSEHOLDS, AND THOSE WHO DID KNOW, MOSTLY REFERENCED THE FEDERAL EMERGENCY BROADBAND BENEFIT (EBB) PROGRAM AND WERE UNAWARE ABOUT ITS SUCCESSOR PROGRAM NOW CALLED THE "AFFORDABLE CONNECTIVITY PROGRAM (ACP)."
- <u>12</u> LISTED A SMART PHONE AS THE ONLY DEVICE THEY USE TO ACCESS THE INTERNET.
- THE AVERAGE SATISFACTION RATING FOR THE FOCUS GROUPS EXISTING INTERNET SERVICE WAS ABOUT <u>3.5</u> IN A RATING FROM 1 TO 5.

"I plan to use the internet more. It's getting difficult to get things done without it."

"I pay a high price b/c internet service is essential. Low cost offers= low speeds."

"Often there isn't a connection or its often interrupted."

"ISP needs to fix the boxes outside and invest in better equipment."
