Guidelines for Submitting Comments via Online Form:

- There is a 4,000 word/2-page limit for each comment.
- When a comment is received, it becomes public record and will be made available to the public on the CPUC's website. However, there is an option to make your comment private.
- You must include your first name, last name, city, state, zip code, and email address. This information, excluding your email address, will be publicly displayed on the
- CPUC's website with your comment unless you chose to make your comment private.

Parties to CPUC proceedings may, but are not required to, respond to written comments received from the public (see Public Utilities Code <u>section 1701.1(g)</u>). Parties may do so by posting such response using the "Add Public Comment" button on the "Public Comment" tab of the docket card for the proceeding.
